RULES: High School rules will be followed at the meet.

Award Presentation: Awards for the top 10 performers in each event will be presented at the conclusion of each dive event. The coach of the 1st Place diver of the event will be the presenter.

DIVER

ELIGIBILITY: The diving standard for entry is that the diver must have scored at least **130 points** for 6 dives and **240 points** for 11 dives during any Gwinnett High School diving competition this school year and that they have successfully completed every dive they entered in this meet at least once in a practice or a meet. PLEASE NOTE: Diving scores used to qualify for the county championship must be earned at a GCPS High School meet. To compete at county A diver must be able to complete an 11 dive format, matching dive order requirements for state but without the mandatory state DD's.

ENTRY LIMIT: Entrants may be entered in a total of 4 events, (Max. 2 individual). Each relay and each diving entry counts as one event towards the 4. Once entered in an event, the entrant is expected to dive that event.

ENTRIES: All divers must fill out and sign the 11 dive form and turn it into their diving Coach. Dive coaches must then turn in the signed dive sheet to the diving meet director and the school coach must enter their diver with their team entries on Hy-tek and turn in to Meg Rooney by the deadline of Friday 1/21/11.

ENTRY

DEADLINE: The entry deadline will be **Sat., January 15, 2011 at 11:00 PM**. Signed dive sheets must be received by Cori Hamm. Divers and coaches can contact the Diving Director with entry changes at dive.coach.hamm@gwinnettswimdiver.org or 404-444-0437. The deadline for changes is Monday Jan. 24,2011 at 9:00 PM.

NO SHOWS: Failure to compete in an entered event will result in the swimmer or diver being disqualified from further competition. A swimmer or diver may be excused from swimming or diving an event by declaring a "False Start" to the Referee prior to the first heat of the event. Events with declared false starts count as one the 4 events. To expedite the scoring of the meet please provide a list of known declared false starts to the Meet Referee prior to the start of the meet.

FORMAT: This will be an 11-dive format. Matching the dive order requirements for State Meet, but without the mandatory State DD's. This event counts toward the entry limit of four (4) events as set forth in the Entry Limit section below. The school coaches should make sure that these standards are communicated to the divers – especially those that do not practice at Collins Hill, Mountain Park, West Gwinnett or Bogan pools. No one, including swim and dive coaches, has the authority to enter any diver that fails to meet the qualifications.

SWIM/DIVE

OFFICIALS: Referee, Diving Judges, Stroke Judges and Starter will be staffed by Georgia High School certified officials. GIOSHA.

WORKERS: All teams are expected to provide the workers they are assigned. All workers must work the entire scheduled session.
